## EMBASSY OF THE CZECH REPUBLIC IN TEHRAN – CONSULAR SECTION

## The documents to be submitted to apply for a short-term visa (up to 90 days) are as follows:

1) <u>Iranian passport</u>, with a validity of not less than three months after the date of expiry of the required visa, copies of data pages, previous visa(s) and stamps. Presenting the old (invalid) passport(s) is recommended.

2) Filled <u>application form</u>, typed and signed by the applicant (or a parent in case of children).

The application form can be downloaded from *www.mfa.cz/visaform* (pdf format) or *www.602.cz/mzv* (xml format). The application must be presented by the applicant <u>personally</u>.

3) One recent colour <u>photo</u> of the applicant's face,  $3.5 \times 4.5$  cm, with white background, attached (glued) to the application form (please do not staple the photo to the form).

**4)** Original <u>invitation form from Czech Immigration Police</u> (i.e. pink form of "POZVANI", with hologram, signed and stamped by the Czech Immigration Police) and its copy.

**4a)** For scientific conferences, the <u>original invitation</u> of the conference on headed paper and not-scanned signature of the Czech inviter is exceptionally acceptable. It is recommended to present the abstract of a paper or a lecture prepared for the conference.

5) <u>Accommodation document</u>, i.e. hotel voucher(s) or a confirmation from the inviter at which address the person will stay in the Czech Republic (in case it is not filled in the above mentioned Czech Immigration Police Invitation on the second page).

**6**) The original <u>invitation letter</u> from the Czech inviter specifying inter alia the applicant's name, date of birth, passport number and the purpose of travel.

7) The original <u>recommendation letter</u> from applicant's <u>employer</u> in English (usually an Iranian company), specifying name, date of birth, passport number, applicant's position in the company, monthly salary, the purpose of travel and the estimated period of stay. If the employer takes responsibility for the travel expenses and guarantees applicant's return to Iran, it should be mentioned in the letter.

7a) The <u>recommendation letter of university</u> together with university ID card is acceptable.

8) An official proof of the existence of the employer's company (i.e. Registration notice published in an official newspaper, a copy of the company's Registration document).

**9)** A document proving the financial situation of the applicant as a <u>bank statement</u> and/or a <u>personal</u> account balance printout from the last six months – in English or translated;

A copy of a valid international credit card is acceptable (while presenting the card itself).

**10**) International <u>health insurance</u> policy with validity of the applied duration of stay (at least). It is recommended to have insurance for slightly more days than the planned lenght of stay.

**11**) A copy of the <u>airplane ticket</u>. It is acceptable first to submit a print of the ticket reservation and the copy of the airplane ticket later when the visa is issued.

12) A copy of <u>Iranian ID card</u>.

## NOTE:

- Payment in cash (60,-EUR) is required when applying. The application fee is non-refundable.
- Insufficient documents or misleading information or data will result in visa refusal.
- There is no guarantee that visa will be granted. The visa process takes cca 2-3 weeks.
- A copy of a document is acceptable only while presenting its original (e.g. airplane ticket).
- All documents must be either in English or Czech. Documents in Farsi are not acceptable.
- The Embassy reserves the right to require further documents or additional interview.

- □ Accomodation
- Employer recommendation letter + registration notice
- $\square$  Bank statement + 6 months circulation
- Health insurance
- Copy of airplane ticket (or flight reservation)
- **C**opy of Iranian ID card

If I did not ✓ cross-mark ✓ every item I am aware that it can result in visa refusal.
