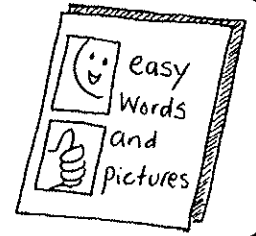

What is the CCRC?

The CCRC looks into cases where someone thinks they were wrongly convicted, or that their sentence was wrong.

Fill in this form if you think you were wrongly convicted and we can look into it for you.

If we think there is something wrong with a conviction or a sentence we can send the case to the appeal court where it will be heard as an appeal.

It normally needs to be something that has not been heard by a court before.



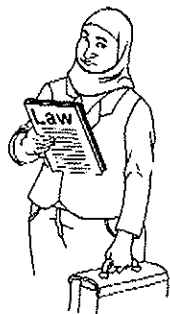
