Sub-licence Agreement

have entered into the following Sub-licence Agreement on the basis of Section 2363 et seq. of Act No. 89/2012 Coll., the Civil Code.

Article I. Preamble

- 1. On 26 September 2016, the Sub-licensor entered into a Contract for Work (ref. 115412/2016-OVD) with Intuitive Production, s.r.o., registered office: Adamovská 803/1-Michle, Praha 4, postcode 140 00, business ID 01390309, tax ID CZ01390309. On the basis of this Contract, Intuitive Production, s.r.o. granted the Sub-licensor an exclusive licence to use an audiovisual work entitled "Czechia has marvellous people" with a total duration of 5 minutes and 6 seconds, created for the Sub-licensor by Intuitive Production, s.r.o. The licence is not limited to any specific time and territory and permits the audiovisual work to be screened using analog as well as digital media.
- 2. Article 3, paragraph 5 of the Contract referred to in paragraph 1 above permits the Sublicensor to grant its licence rights to third parties (sub-licensing).

Article II. Object of the Agreement

On the basis of this Agreement, the Sub-licensor grants the Sub-licensee, free of charge, the right to use the audiovisual work described in Article I, paragraph 1 for screenings using analog as well as digital media, in particular a CD, DVD and USB flash disc.

Article III.

Rights and obligations of the Sub-licensor and the Sub-licensee

- 1. The Sub-licensee agrees to use the audiovisual work on a non-profitable basis, strictly and exclusively for the promotion of the Czech Republic abroad. The Sub-licensee shall not have the right to manipulate, adapt or alter the audiovisual work or any part thereof. The Sub-licensee shall not have the right to make the audiovisual work available to third persons.
- 2. The Sub-licensor grants the licence to the Sub-licensee for an indefinite period of time.
- 3. The Sub-licensor shall have the right to terminate this Agreement immediately without cause.

Article III.

Final provisions

- 1. This Agreement may not be changed or modified except by written amendments signed by the authorized representatives of the Parties.
- 2. Matters not covered by this Agreement shall be subject to Act No. 89/2012 Coll., the Civil Code, as amended.
- 3. The Parties declare that they have read this Agreement before signing, and that they enter into this Agreement of their earnest, free and clearly expressed will. In witness of their agreement on the provisions of this Agreement, the persons authorized to act for the Parties have affixed their own signatures hereto.
- 4. Pursuant to Act No. 101/2000 Coll., on the Protection of Personal Data and on Amendment to Some Acts, as amended, the Sub-licensee gives its consent to the processing of personal data by the Ministry of Foreign Affairs for the purposes of the sub-licence. This Sub-licensee's consent is valid for the duration of this Sub-licence Agreement.
- 5. This Agreement shall enter into force and effect on the date of its signature.
- 6. This Agreement is done in two identical, equally authentic copies, one for the Sub-licensor and one for the Sub-licensee.
