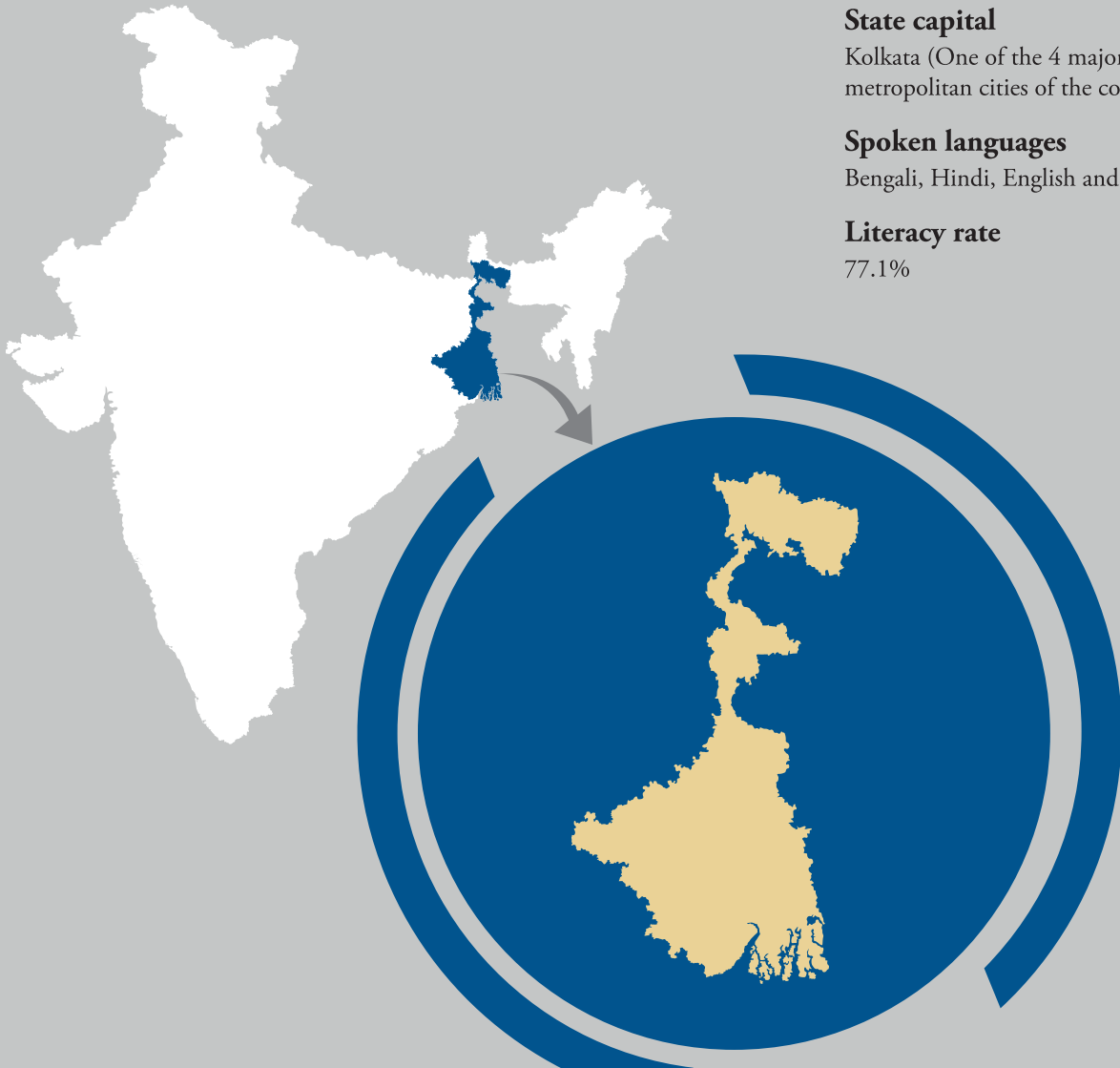

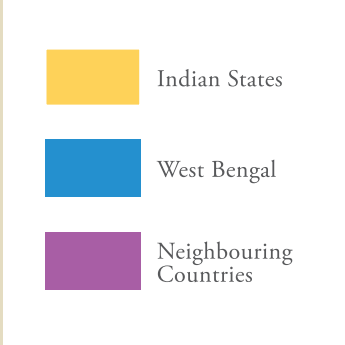
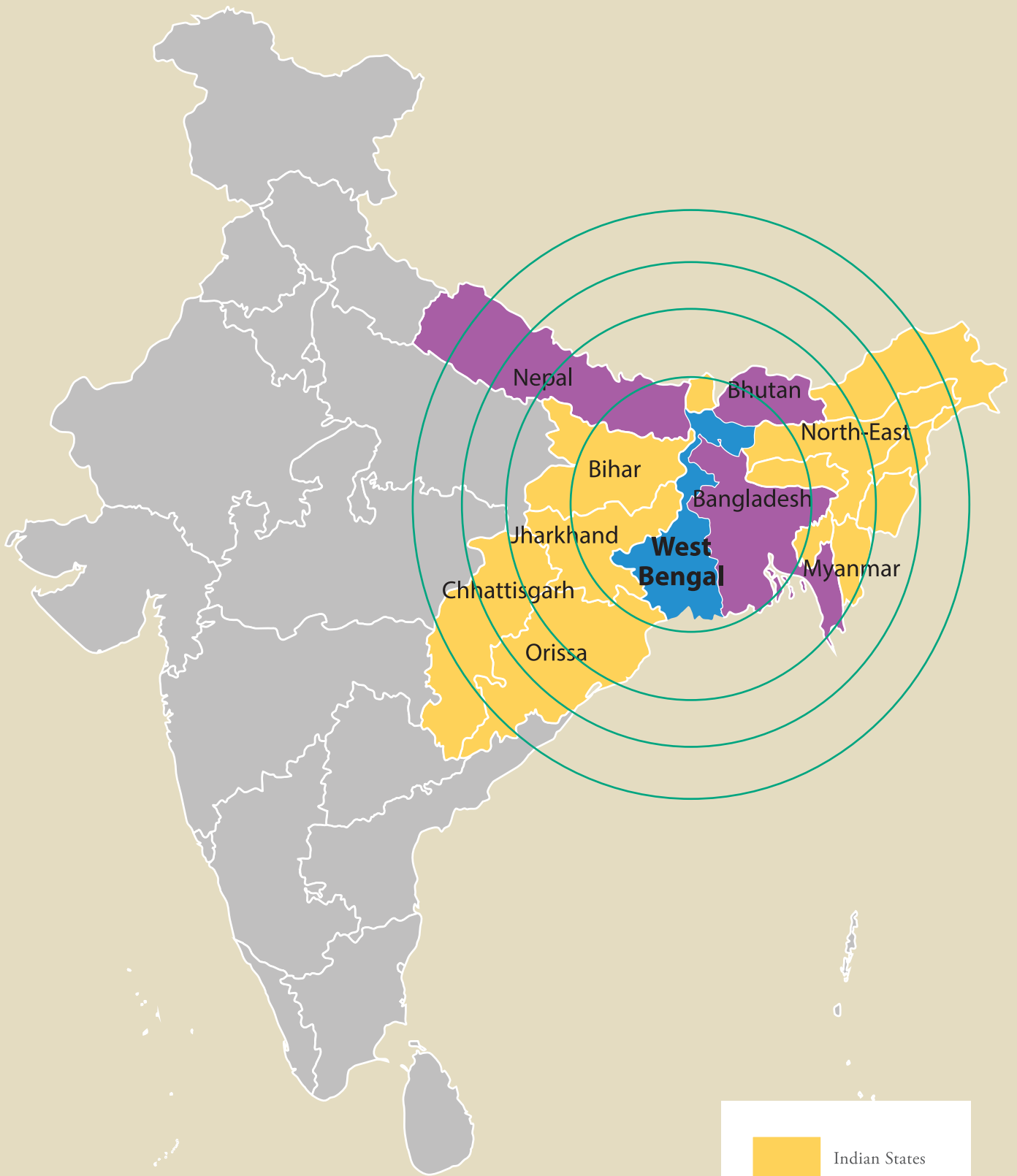

EXCELLENT CONNECTIVITY

DOMESTIC & INTERNATIONAL

- Population base covered corresponds to more than 1/4th (~ 27.5 %) of India's total population
- Caters to nearby states – Bihar, Jharkhand, Odisha, Chhattisgarh, and North-East India (including Assam)
- Considerable chunk of population base (0.2 Billion) resides in neighboring countries viz. Nepal, Bhutan, Myanmar and Bangladesh
- Beyond these, whole of South-East Asia is easily accessible
- Vast road network of 3,15,404 KM
- ~4,000 KM of railway tracks
- 950 KM of Waterfront
- Leading in the country in terms of spread, density, reach, etc. of National Inland Waterways

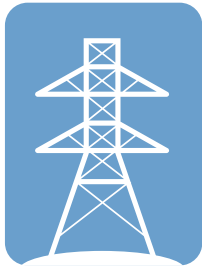


Maritime: Connectivity and Potential

- Launched 'myEnterprisewb' portal to provide quick and simple way to access all information and requirements of setting up an MSME unit in the state and incentives provided by government.
- 'Micro Business Credit Card' scheme launched for small and medium businesses in the state in association with the State Bank of India with a fund of ~US\$ 30 million

- Market value of fixed assets amounting to ~US\$ 5.9 billion
- MSME growth in the state, figures as one of the top achievements of the incumbent Government
- 343 MSME clusters taken up for development
- Highest bank credit flow to MSMEs of ~US\$ 15 billion in the last 5 years

- Road density higher than national average

MARITIME

- Oldest maritime infrastructure with 2 major Ports at Kolkata and Haldia
- Upcoming major deep sea port at Sagar Island and proposed deep sea port at Tajpur and another port near Kulpi



POWER

- Ranks No 1 in Power Availability in the Country
- Highly efficient 100% spot billing facility to low voltage domestic and commercial customers



TELECOM

- Kolkata offers about 580 Mbps of international satellite connectivity through Tata-owned Videsh Sanchar Nigam Limited (VSNL) and Software Technology Parks of India (STPI)

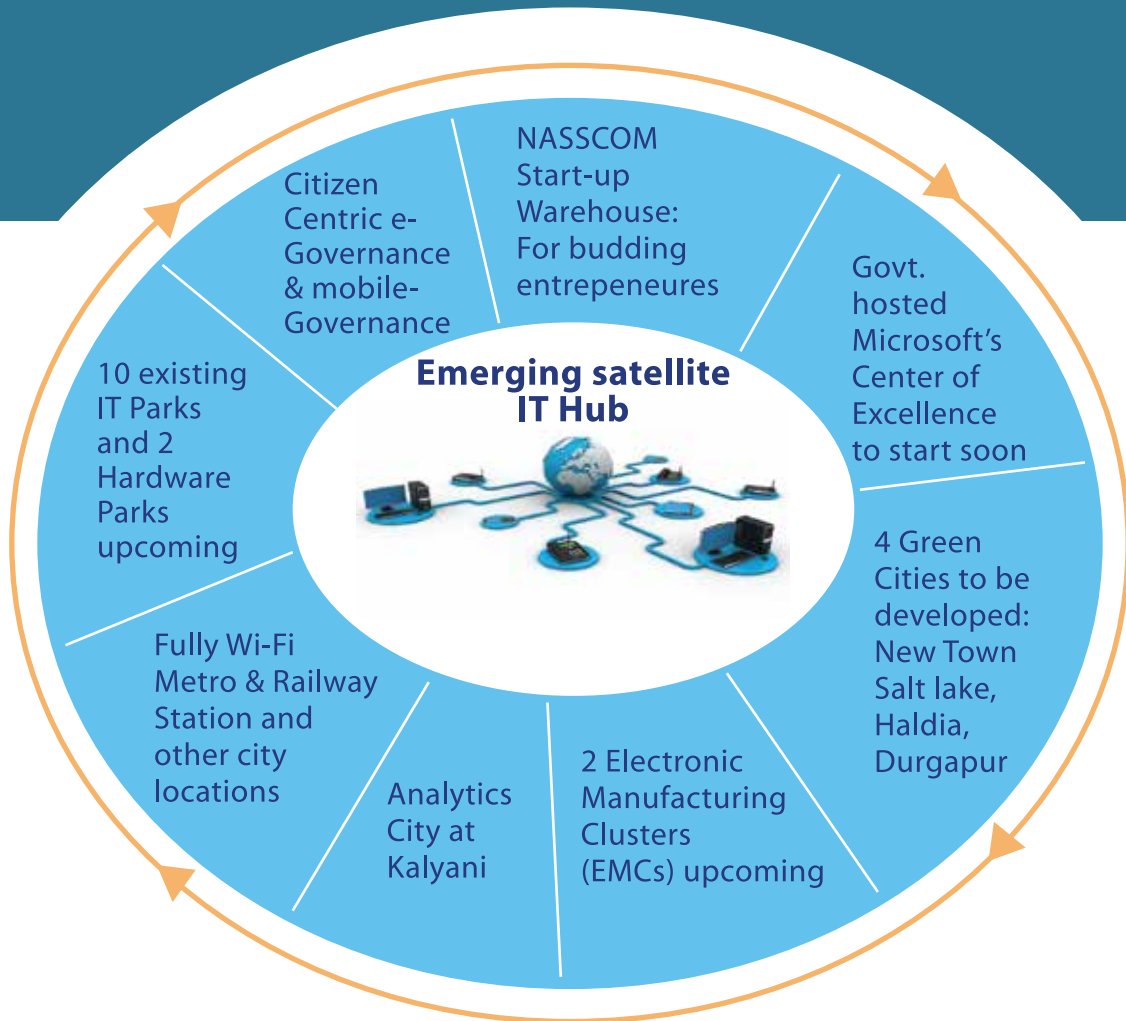

EXCELLENT SOCIAL INFRASTRUCTURE



Human Capital

- allocated US\$ 1.5 billion to the School Education Department for the next financial year
- Construction of 28 Model schools have been completed
- 199 nos. of new set up Primary and 71 nos. of new set up Upper primary schools have been constructed
- Since 2011, 15 new universities and 46 new colleges have come up in the State
- As a result of the significant increase in public spending in higher education, the State's Gross Enrolment Ratio has risen dramatically to 17.5 from 12.6 in 2011
- US\$ 0.01 billion allocated to set up Virtual classrooms in all higher education institutions
- The budgetary allocation for the Swami Vivekananda Merit cum Means Scholarship Scheme has been raised by 5X in 2016-17
- Allocated US\$ 0.09 billion to the Higher Education, Science & Technology and Bio-technology Department for the next financial year
- 'Utkarsh Bangla' has been launched with an aim to skill 12 lakh people in two years
- 10 new Government Polytechnics and 01(one) Government Sponsored Polytechnic were operationalized in 2016
- Allocated US\$ 0.12 billion to the Technical Education, Training and Skill Development Department for the next financial year

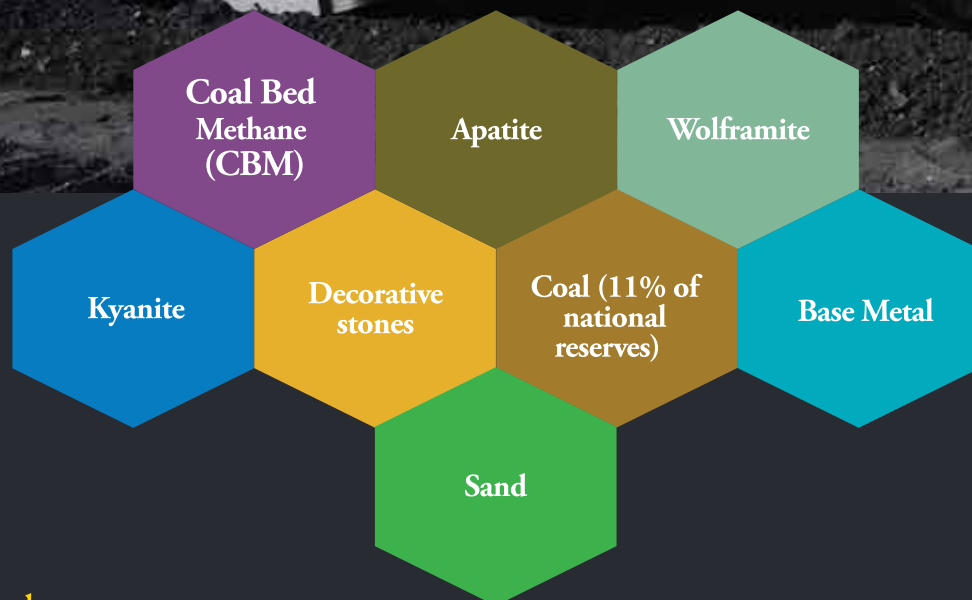


Health and Education Initiatives

- State to promote free treatment policy by withdrawing all kinds of user Charges for all sorts of investigations, medicine & beds from all Government facilities
- initiated a process of setting up of 13 Mother and Child Hubs (MCH)
- To provide comprehensive neonatal care, 303 Sick New Born Stabilization Unit (SNSU) have been made operational
- Infant Mortality Rate (IMR) has been reduced from 32 to 26 and Institutional Delivery in health centres and hospitals has increased from 65% to 90%
- Another 5 new Government run Medical Colleges at Cooch Behar, Raiganj, Purulia, Rampurhat, and Diamond Harbour are coming up by upgrading the district hospitals
- 112 Fair Price Medicine Shops (FPMS) are functional and 7 are expected to be made operational in phases
- Fair Price Diagnostic Centers and Dialysis Services have been set up at 46 State Run Facilities across the State
- A Comprehensive Group Health Insurance Scheme named “Swasthya Sathi” has been introduced
- US\$ 0.5 Billion allotted to the Health and Family Welfare Department



RESOURCE ABUNDANCE ACROSS VARIOUS STREAMS

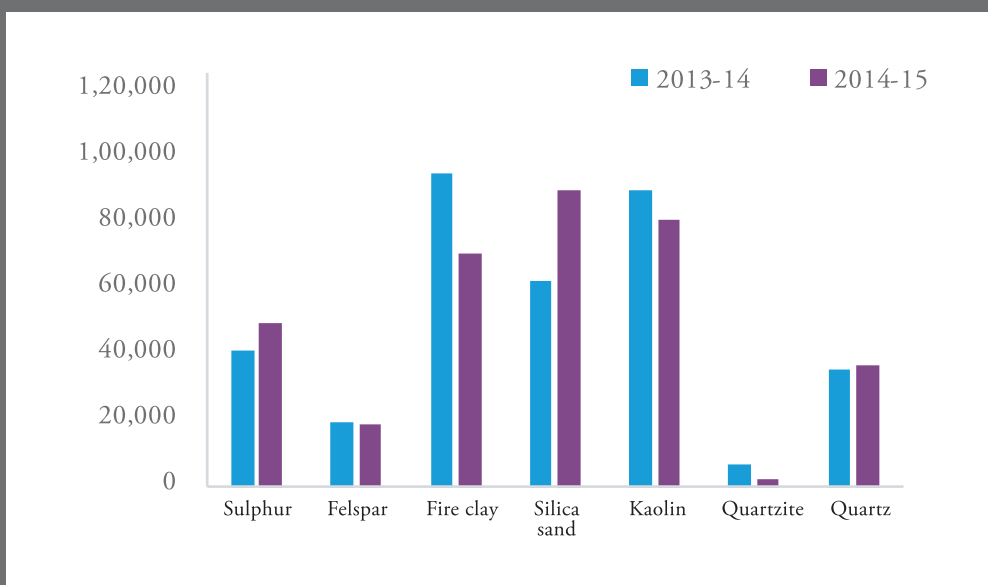


Highlights

- As of April 2015, state's total coal reserves were estimated at ~31 billion tonnes, major coal fields being at Raniganj, Barjora etc. while coal production in West Bengal has reached ~5 million tonnes during 2015-16 (April-June 2015)
- Rock phosphates deposits are found in Beldih, Chirugora and Kutni regions of Purulia district
- Deposits of granite and kaolinite are found in Purulia, Bankura and Birbhum districts
- Deposits of basalt-trap rocks used to prepare road metals are available in Birbhum district

- There is an increase in trend in the overall mineral production over the two years
- Sulphur and Silica sand had a spur in production due to unveiling of new deposits

PARADIGM SHIFT IN LABOR POLICIES

- The State moved to a 'No Bandh' (meaning there are no strikes/ lockouts) regime to ensure that the companies, businesses, offices and public are not disturbed and to ensure a disciplined work atmosphere in the state.
- Man-days lost drastically reduced in from 6.5 million in FY 2010-11 to 5,200 to FY 2012-13 and subsequently to almost nil in 2015-16
- Additionally the State has taken a slew of initiatives that is heralding new era in labor management
- Nearly 7.6 million beneficiaries have been enrolled under the various social security schemes run by the State Labor Department
- Approx. US\$ 2 billion has been disbursed so far in various types of benefits to nearly 1.3 million unorganized workers under the schemes

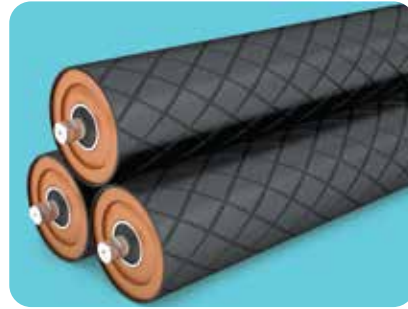
