DESIGN AND RETAIL

- Czech Glass, Porcelain, Ceramics
- Companies must be ready to invest
- PATIENCE! PATIENCE! PATIENCE!
- <u>Regular participations at fairs</u>
 - Tabletop: NY NOW (two times per year)





1. Important Sectors for Czech Goods and Services in the Jurisdiction of the CG New York

Design Glass, Contemporary Design, Fashion

- NY = entrance gate to the US (eager to accept new trends and <u>brands</u>)
- Construction of hotels and high-end office and residential spaces
- Specialized accelerators (Council of Fashion Designers of America Incubator, Favors Fashion Incubator etc.)



1. Important Sectors for Czech Goods and Services in the Jurisdiction of the CG New York

IT Sector

- Important decision: What am I looking for? Investor or client?
- NY = enormous and growing liquidity of capital (VCs, Angels)
- Large infrastructure incubators, accelerators
- Conferences and Fairs: Tech Crunch Disrupt New York, Tech Day
- NYC portal: Digital.nyc
- Other hubs: Pittsburgh, Boston

CONSTRUCTION

- Construction boom in NYC
- Back at 2007 and 2008 growth rate
- 2017: construction investments in NYC 35 billion USD
- Potential for Czech companies: interior elevators, high-end tiling, coverings, etc.
- Success story: STROS Sedlčanské strojírny a.s.

NUTRITIONAL SUPPLEMENTS

- Healthy lifestyle
- Effect of an "European product"
- Kosher certification = significant advantage
- The more "exotic" active substance, the better

R&D, BIOTECHNOLOGY, LABORATORY DEVICES

- North-East of the US enormous concentration of laboratories
- Universities (MIT, SUNY, CUNY, UMass nanotechnology great demand for imaging devices: microscopes, spectroscopes)
- Green technology, recycling "2030 Zero Waste Management Agenda"
- Other NYC Projects: IN2NYC (CUNY Partnership)

 - Office space in Meopta premises

Cílem této webové stránky zřízené Generálním konzulátem ČR v New Yorku je poskytnout českým firmám celistvý přehled o možnostech dodávek pro Organizaci spojených národů (OSN), která je se svým ročním nákupem zboží a služeb v souhrnné výši přes 17,5 miliard amerických dolarů (cca 437 miliard korun, což je přibližně 10 % státního rozpočtu ČR) potenciálním lukrativním odbytištěm českých výrobků a služeb.

Z pohledu dosavadních čísel potenciál tohoto lukrativního trhu není českým podnikatelským sektorem příliš využitý. Smyslem tohoto portálu je proto přiblížit českým firmám podstatu dodavatelského svstému a podat aktuální informace, které by mohly pomoci zvýšit podíl českého zastoupení na celkovém objemu zakázek OSN.

Jste-li majitelem či představitelem české firmy a doposud nemáte s obchodováním s OSN zkušenosti, měli byste na této stránce nalézt základní informace potřebné pro orientaci v problematice, které mohou Vaší firmě otevřít dveře na tento všestranný a perspektivní trh.
