3. Description of Problem, Suggested Intervention and List of Items

The war in Gaza has caused an almost complete shutdown of the Bethlehem economy. The current absence of pilgrimages and the rescinding of Jerusalem work permits has left about 90% of the workforce without salaries. There is increasing poverty and food insecurity, which impacts women and children in an outsized way. Families are forced to choose between groceries and healthcare. To ensure the lowest barriers to care, Holy Family Hospital has increased its subsidies for care from 50% to 75% and two social workers are available to move the sliding scale to zero patient fees for the poorest families to ensure that no one is turned away for need. Holy Family Hospital cares for all in need without regard to need or creed. The Hospital restores hope and dignity to the women and children of greater Bethlehem.

Holy Family Hospital is committed to caring for the most fragile and vulnerable, especially in this time of great need. The budgetary impact of decreased patient fees has necessitated a focus on meeting payroll and providing full services. Equipment needs are extremely important, but at this time they have been inevitably pushed to a secondary focus due to a lack of funds.

Therefore, in order to meet the needs of our patient base, we would welcome very much the following items:

- 4 Phototherapy Led Lamps
- 1 Operating Table
- 1 Surgical Set
- 1 Set of Operation Theatre Equipment

This equipment will be put into use upon receipt and should have a lifespan of ten years serving the medical needs of hundreds of babies and thousands of women for the lifetime of the equipment.

Data protection information

The following information is provided on the basis of Article 13 of the GDPR¹:

I.
