



# **CZECHIA AND DRR**

Disaster risk reduction and climate resilience have been long term priorities for the Czech humanitarian and development assistance.

That is why Czechia cooperates closely with relevant international stakeholders to promote the implementation of DRR activities worldwide.

#### Sendai Framework

Czechia took direct part in the drafting of the Sendai Framework for Disaster Risk Reduction 2015 – 2030 and, together with Japan, proposed and piloted indicators for the respective goals of the Sendai Framework.

#### **Cooperation with UNDRR**

Czechia is a regular contributor to the UNDRR budget. The contributions are un-earmarked, allowing UNDRR to use it for the most pressing purposes.

Czechia cooperates with UNDRR on the implementation of the Sendai Framework in fragile countries.

Czechia also promotes the implementation of the UNSG Initiative Early Warnings for All.

In 2022, UNDRR was one of leading partners for the Czech EU Presidency on the DRR and Climate Security priority – resulted in first ever Council Conclusions on DRR in EU external action (DRR Conclusions).

Mami Mizutori was key speaker in the Czechia for Climate week in September 2022, with <a href="Prague Appeal on Adaptation">Prague Appeal on Adaptation</a> as the key outcome.

Czechia with UNDRR organized workshops on elements of early warning systems for fragile countries in the I. and II. <u>European Humanitarian Forum</u>.
