



Charles University in Prague (CU)

- founded in 1348 by the Holy Roman Emperor Charles IV
- belongs among the oldest, largest and most prestigious universities in the world
- ranked among the top 2% of the world's universities in Shanghai University's *Academic Ranking of World Universities*
- the number one university in Eastern Europe according to the *Webometrics Ranking of World Universities*

Faculty of Social Sciences, Charles University in Prague (FSS CU)

- the second newest faculty of Charles University in Prague
- founded in 1990, shortly after the Velvet Revolution
- some of the highest quality English language Bachelors, Masters and PhD degree programmes in Central and Eastern Europe in all fields of social sciences
- 4 000 full-time students; approximately 150 of them are enrolled in one of our English language degree programmes
- one of the highest international mobility participation rates of all the faculties of Charles University; yearly we welcome approximately 500 exchange students from all over the world
- top lecturers and leading figures in the policy making, economic and social life in the region
- many of our alumni continue their studies at top world universities in the United States and the United Kingdom (Harvard, Columbia, LSE, Cambridge, Oxford etc.) or they succeed in competitions for highly qualified jobs

Tuition fees and deadlines

- The tuition fee for most programmes ranges from €6,000 to €7,000 per year. The fee for the BECES programme is €7,800 per year. The fee for EU students (including EEA-EFTA) for the IMESS programme is €9,000 per year. The fee for students from outside of the EU (including EEA-EFTA) is €15,500 per year.
- Students can apply for a number of external [scholarships](#) to cover the tuition fees and living expenses.
- The application deadline for the 2013/14 academic year is **15 April 2013** for the Bachelors and Masters degree programmes and **30 April 2013** for the PhD degree programmes.
