2. CANCELLATION

The Contract shall be cancelled and no refund shall be made if the applicant cancels his/her participation for any reason whatsoever, after submitting his/her application.

3. PROTECTION OF EXHIBITS

A) The Organizer shall undertake, with the care of a competent manager, the protection and maintenance of the exhibition hall as a whole;

B) The custody of exhibits and related material remains under the responsibility of each exhibitor;

C) The Exhibitor is required to insure his exhibits and related materials, removal and display and also take necessary measures to safeguard those exhibits and materials.

4. EXEMPTION CLAUSE
