UNV Full Funding Programme



In 2019, 605 UN Volunteers were fully funded by 19 partners to support the United Nations system in 101 countries. Of these, 207 assignments were in sub-Saharan Africa, 145 in Asia and the Pacific, 112 in the Arab States, 85 in Europe and the CIS, and 59 in Latin America and the Caribbean.¹

By funding UN Volunteer assignments, Member States and other partners contribute to volunteerism as a means to achieve the Sustainable Development Goals and bolster the impact of the United Nations across the world. In addition, partners offer volunteers – mainly their nationals – a chance to gain on-the-ground experience in sustainable peace and development efforts. UNV's Full Funding programme provides professionals and young people, including university students, a unique opportunity to support the work of United Nations worldwide.

During 2019, UNV continued to engage with its partners on the mobilization of UN Volunteers through full funding of their assignments. The Full Funding programme sponsored 605 UN Volunteers worldwide – an increase of more than 8 per cent on 2018 – covering a wide range of assignments matched to the needs of United Nations partners on the ground.


New partnerships in 2019

New partnership agreements on full funding for UN Volunteer assignments were signed in 2019 with the Governments of **Australia** and **Kazakhstan**. The partnership with the Government of Australia provides full funding for UN Volunteer assignments for Australian nationals mainly in the Pacific focusing on human rights, particularly disability inclusion, gender and United Nations reform. The Government of Kazakhstan signed a partnership with UNV to fund international specialist and youth UN Volunteers for 2020. Furthermore, following the successful implementation of a one-year pilot, the Government of the **Russian Federation** signed an agreement to deploy Russian citizens as international UN Volunteers over the next three years.

Also in 2019, **Mount Kenya University**, a private university in East Africa, signed a memorandum of understanding with UNV making volunteering opportunities available to students under a national UN Volunteer programme for universities. A cooperative arrangement between the **Chinese Youth Volunteers Association** was also signed in 2019. This marks the first cooperation between UNV and China at the national level, deploying UN University Volunteers and UN Youth Volunteers from 2019 to 2021.

Also in 2019, the Governments of **Finland**, **France** and **Sweden** provided full funding resources for the mobilization of UN Volunteers with disabilities in support of the United Nations' pledge to "leave no one behind".

Without monitoring and evaluation, you cannot measure the impact of our work on the ground, especially to see if the intended effects of United Nations interventions are working or not. Volunteerism is something that everyone can do, no matter their economic status or their geographical boundary. **Anastasia Baskina**, a fully funded specialist UN Volunteer from the **Russian Federation**, is currently serving as a gender and human rights officer with the Office of the United Nations Resident Coordinator in **Cambodia**.

46 As a UN Volunteer, I initiated, designed and facilitated the first UN-Civil Society Organization Dialogue on Sustaining Peace in Cambodia, which strengthened United Nations cooperation with civil society in the country. I also had a chance to provide trainings on conflict analysis and resolution to the Cambodian Ministry of Foreign Affairs and International Cooperation and the Association of Southeast Asian Nations Parliamentary Fellows and youth leaders.

Professional outcomes for fully funded UN Volunteers

In a UNV survey of fully funded UN Volunteers who completed their assignments between 2008 and 2019, respondents reported that they highly valued the experience as contributing to their personal and professional development. A total of 93 per cent of respondents indicated that their UN Volunteer assignment had been valuable for their career development and employment prospects, and an impressive 67 per cent had gone on to work in peacebuilding and international development cooperation following their UN Volunteer experience.

Sue Nguyen, a fully funded UN Youth Volunteer from the **Czech Republic**, served with **UN Women** in **Viet Nam** in women's economic empowerment in 2018–19.

46 I focused on cooperation with the private sector that employed women in their factories and shared value partnerships so that the private sector can help the United Nations fulfil its mission for equality for women's rights in the workplace. I focused on Vietnamese and multinational businesses following women's empowerment principles. I became a UN Volunteer as it was a great opportunity for me to come back to the country of my parents' origin.

Nelly Mandengue, a fully funded specialist UN Volunteer from **France**, served with **UNDP** in the **Central African Republic** from 2017 to 2019 in communications to support the rule of law and national reconciliation.
